Buildings	As a matter of clarification, the date of disposal of category 'B' buildings should be within 5 years of the approval of the Presbytery Mission Plan 31st December 2027, it is anticipated that clearer timescales will be available by 31st December, 2025 allowing for reviews of buildings to be completed and final Presbytery decisions being made. This issue may also be impacted by that of Tenure in some circumstances. (p35)
Adjustment	It is anticipated that a number of congregations who have already held extensive and progressive conversation with partners and who have outline agreement already in place, will move to formal adjustment, be that linkage or union, very quickly after the formal approval and concurrence with this plan. All other congregations are encouraged to engage constructively to facilitate adjustment as soon as possible and it is anticipated and expected that adjustments will be concluded by 31st December 2025, subject to necessary vacancies arising.
